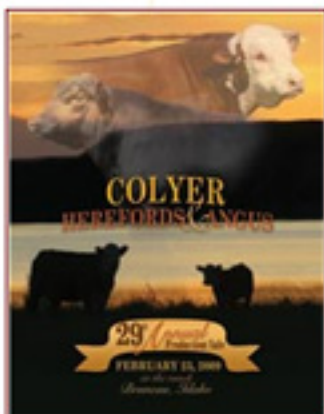

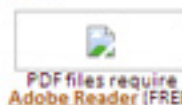
DOWNLOADING TIPS
